- 3. The only difference between the S-11716 and S-11716-0001 and locking systems is that the S-11716 is supplied with a silver coloured handle and the S-11716-0001 is supplied with a green coloured handle. The functionality of those locks is identical.
- 4. The 'Plus' rating indicates the cylinder meets the requirements defined in Annex A of BS 3621: 2007 or manipulation resistance class '1' defined in LPS 1242: Issue 2.
- 5. The resistance of the mechatronic cylinders to 'non-mechanical' attack has not been assessed as it is outside the scope of LPS 1175. Likewise, the approval does not cover possible effects of any susceptibilities relating to the functionality and performance of ancillary equipment that may be used in conjunction with those cylinders. It is therefore recommended that specifiers satisfy themselves that the components used are either resistant to electronic methods of attack, or that they are suitably protected from such tampering/abuse and are resistant to any environmental conditions/interference that may cause the locking system to disengage.
- 6. The compatible Abloy padlocks are approved for use when bearing an alpha-numeric code denoting the date of manufacture as December 2013 or later. Alternatively, the V01 version of the equivalent padlock may be used without undermining the security rating.
